All cash (bills, coins); exact fare, no change given.

TAP CARDS

To ride Commuter Express using a TAP card it must be loaded with one of the following fare media:

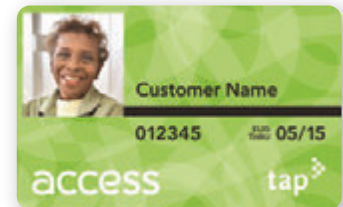
- Commuter Express Trip Ticket
- Commuter Express 31-Day Pass
- EZ Transit Pass (Monthly or Annual)
- Stored Value (cash)

TAP CARD, REDUCED
Only Stored Value or Commuter Express pass (NO Metro passes accepted)



ACCESS SERVICES ID CARDS
(PCAs must pay separate fare)

Please be sure your card loaded with the correct fare media and has a TAP logo.
(The TAP card can hold fare media on any of the 24 TAP-participating transit systems throughout Los Angeles County.)

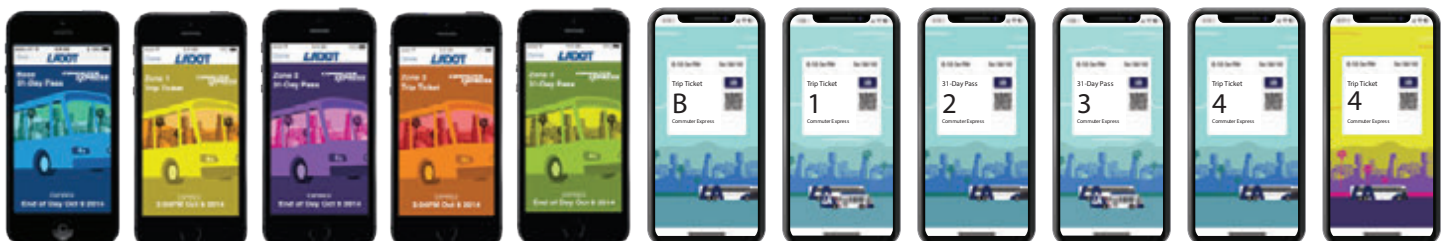

LA Mobile tickets have all the same information as other fare media:

- Ticket Type
- Ticket Expiration / Valid-Dates

COMMUTER EXPRESS TRIP TICKET OR 31-DAY PASS

LIGHTS ON



Dead batteries are the same as lost tickets - valid fare is required to board.

PUT IN FARE BOX



OneRide Trip Ticket: Base and Zone 1-4. Colors may vary; the correct Zone number must be presented.

Metro token: \$1.50 value, one token is accepted for base fare - zones 1-4 require extra cash fare.

(No longer accepted after November 29, 2019)



SHOW TO DRIVER

MUST SHOW A VALID TICKET



Metrolink: Mobile Ticket, Special Round-Trip Ticket, 4-trip ticket, 7 Day Pass, Weekend Pass, One-Way/Round Trip ticket, and Monthly Pass

NOT ACCEPTED ON COMMUTER EXPRESS

- **TAP CARDS with Metro (MTA)** 30-Day, 7-Day, Day Passes or other transit services passes or tickets.*
- **ALL PAPER TRANSFERS (IAT's)** All transfers are now electronic. Rider must use stored value on a TAP card to purchase a transfer; cannot use cash.
- **REDUCED TAP CARDS with Metro** Senior/Disabled 30 Day or Day Pass, College/Vocational 30-Day Pass, Student K-12 30 Day Pass or other transit services passes or tickets.*
*AVTA, Culver City Bus, Foothill Transit, Gardena, Montebello, Norwalk, Santa Clarita
- **TICKETS and PASSES from any other transit agency.** (except as noted).
- **EMPLOYEE ID'S** including Police, Fire, Military, City/County of LA, US Post Office, Metro, LADOT and any other transit agencies.
